AQUARIUS SAILING CLUB MINUTES OF THE ANNUAL GENERAL MEETING HELD AT THE CLUBHOUSE ON SATURDAY 1st December 2018.

The meeting was chaired by the President, Rodger Wheeler, and opened at 7:35 pm.

1. APOLOGIES

Apologies for absence were received from:- Joan Bray, Jean Maracchi, John Neale, Pat Irvine, Anne and Leo Bond, Charles and Mary Dennis.

About 34 members were present, of whom about 27 were members having a vote.

2. MINUTES OF THE A.G.M. HELD NOVEMBER 2017

The Minutes of the Annual General Meeting held on the 2nd December 2017 were approved by the members.

3. MATTERS ARISING

Results of the Questionnaire were received and compiled. Following the suggestions listed in item 7, a full review of the Rules was undertaken during the year by a sub-committee.

The paving slabs for the trailer park (budgeted as £800) and replacement timber flooring for the quarterdeck (budgeted as £1,500 to £2,000), had both been undertaken this year.

4. COMMODORES'S REPORT

A report was prepared and presented by the Commodore John Botterill. Photos of the year's activities were shown as a slide show during the subsequent refreshments.

"Sailing wise and Social wise we have had another good year.

The weather has been fairly good for sailing – I have a photograph here of sailing on the 25th February (shown).

Our socials have given much pleasure to all those who come along, for which particular thanks to Diana and all her helpers.

We have however had difficulties with administration. I see two factors:

- 1) society has become more PC over the last 10 or so years which is a good thing; but
- 2) society has become more aggressive a "me" culture which is not a good thing.

We have always strived to achieve a committee which exercises sound judgement, contributes to the club, and works hard and as a team. This year has been no exception. But I have to say there is a distinct lack of respect for the committee from some quarters.

What does the committee do exactly, I have heard asked. We meet 10 times a year – that's nearly every month, discuss ideas for sailing and socials, decide on priorities for the premises, agree expenditure, seek ways to keep up our presence, and to receive applications from prospective members. Indeed the review of the Rules was a significant task undertaken by a sub-committee,

and condoned by the full committee. At the end of last year Cath organised and issued a survey, your views were carefully analysed and have helped the committee to assess the mood of members and indeed specific suggestions concerning how the club runs.

Our great loss this year was the passing of our near founder George Bray, who died unexpectedly. A more affable yet astute couple one cannot imagine, who have done so much to guide the club during the 70 years which we celebrate this year. Richard has found the Annual Report from the very first year -1948.

We had a stand as usual on Chestnut Sunday in Bushy Park, followed by a good number of prospective members who came along to see us, and to whom we gave a sailing experience. We were again disappointed by the number of these who did join the club, but we do warmly welcome those who have joined at various times during the year. We do ask proposers and seconders to mentor their new member, making sure they become familiar with people and things, and encouraging them to join in to the full.

Bodgits' big job this year was replacement of most of the decking on the quarterdeck outside. My thanks to them and to several members who also gave their time to getting this completed. The other big task was laying paving slabs in the trailer park, our thanks for that one to Bryan as well.

A thank you also to our secretary Jean who doesn't feel able to offer herself for re-election. We would love to have a volunteer step up at some point.

As I have said before, I am always prepared to receive comments and complaints informally from members. I have replied to worthy ones, and brought all those of any consequence to the committee. Or members are quite entitled to make representation to the committee, via the secretary.

I hope next year is successful for Aquarius".

7. ELECTION OF HONORARY MEMBERS

It was explained that under the proposed Rules changes, Emeritus and the two categories of Honorary membership would be combined into one category: Honorary. The Committee

recommendation of: Rodger Wheeler, John Botterill, Nigel Knowles, Mike Baker, Richard Cannon, and Joan Bray had been proposed by the Committee and were clearly accepted by well over % of the voting members present. Based on the current total of membership a limit of 6 applies. In answer to a question it was advised that Tony Hopkins, up till now an Emeritus member, had not been included [he would become a Full member with consequent annual subscription requirement].

8. APPOINTMENT OF AUDITOR

Graham Thompson was again appointed. Graham advised that although quite normal for an Auditor to prepare the end of year accounts sheets, it was felt that someone should be appointed to check his output, for this Rodger Wheeler was appointed.

9. EXPLANATION OF PROPOSED RULE CHANGES

The work of the sub-committee had come up with changes, taking into account suggestions submitted, the most significant ones being :

- 2.1e Social members now entitled Associate, and the longstanding committee policy on acceptance (distance health or age) enshrined into the Rules
 - 2.1f Honorary now just one category, do have vote

Existing rule 4.1d removed - no longer offer of block voting at AGM

- 4.5 Committee meetings attended by appointed members plus any invited by committee
- 5.3 AGM business 21 days was 14 (to give Secretary sufficient time)

The revised version had been issued to all the members in November.

Comments received as a result were considered, the Committee accepted 3 'late changes':

- 3.3 Webmaster to also be an Officer post add n)
- 8.9 Children using club boats supervised rather than accompanied A few typographic errors.

10. REPRESENTATIONS FROM MEMBERS

a) Advised in advance

- 1. Members to comply with club Rules: A member said he considered the Rules to form a contract between the club and members, even whilst admitting the club is not a business in the legal sense. And that there should be no discretion. No examples were offered. Club officers responded that they and the Committee do abide by the Rules.
- 2. Membership application that was declined: A member was unhappy about this. Club officers responded that there was careful discussion at the relevant committee meeting, and that the Committee made a clear decision.
- 3. Postponement of decision on new Rules and By-Laws: A member claimed that the intention was to 'update and streamline', and that they should be plain english. No examples were offered. He wanted the vote on them to be postponed until the Spring of next year. A representative of the sub-committee responded that they had considered all the suggestions prior to their review work, their changes were approved by the Committee (October) and issued to members, of the comments that were then made only two (+ typos) were considered necessary (November committee) as late changes as listed above.

b) Accepted at the meeting

- 1. A member felt that the number of times a guest may attend should be limited, there having been one particular example this year. Club Officers responded that committee have considered this, but would not want to put pressure on prospective members. There is nothing to stop the committee saying enough is enough to any guest, but the one case being referred to was a difficult one.
- 2. A member felt we should make a charge for using club boats. Club Officers responded that whilst the By-Laws allow for this, it is not within our ethos, in particular it would be embarrassing when prospective members go out in club boats for a sailing experience.

11. PROPOSED REVISION OF RULES AND BY-LAWS

Following the discussion in 10a) 3. above, a vote was taken which achieved well in excess of $\frac{2}{3}$ of voting members present being in agreement.

12. ANY OTHER BUSINESS

There was none.

The meeting concluded at 8:45pm.

Following refreshments, Richard and Graham announced the sailing results and awarded trophies and glasses. A full sailing Report was issued by the Sailing Secretary.
